PROTEGA WOOD-C

Transparent fire rated coating for untreated wood materials



PRODUCT DESCRIPTION

Protega Wood-C is a transparent, halogen free, waterborne fire protection coating.

It can be used to achieve fire class B-s1,d0 on interior light coloured wood surfaces. Can be tinted to achieve desired colours.

PROPORTIES

Protega Wood-C is an intumescent paint that foams into a layer when exposed to flames or intense heat radiation from a fire. The layer of foam effectively extinguishes the heat flow of heat to the treated surface.

Protega Wood-C should be sealed with approved topcoat, Protega Topcoat C, in humid conditions (RH >75%) or when a wipeable surface is desired. Protega Wood-C coated with Protega Topcoat C is approved to achieve fire class B-s1,d0.

Apply max. 100 g/m² of Protega Topcoat C. Read more about application on the PDS for Protega Topcoat C.

FIELD OF APPLICATION

Used indoor on wood-based light substrates such as birch, pine and spruce with a thickness of at least 8 mm and density \geq 338 kg/ m³, for B-s1,d0.

These surfaces must always be coated with 250 g/m 2 of Protega Wood-C.

APPLICATION

Ensure that the old coating adheres well and that the surface is free from dust and grease. Work should be avoided at lower ambient temperatures than +10°C. The moisture content of the substrate must not exceed 15%. Apply by roller, brush, air or airless sprayer. Stir well before use. Tools are cleaned in water. Recommended nozzle is 0.011-0.017 (inch) and a pressure of 120-160 bar.

PROTECTIVE MEASURES

Avoid inhalation of spray mist and prolonged skin contact. When spraying, use half or full mask with dust filter II b (St). See product's safety data sheet.

DRYING TIME

At a temperature of min. +23°C and a relative humidity of max. 50%, the following guidelines apply:

Approx. 1 h for each layer.

Can be covered with Protega Topcoat C, after approx. 4 h.
